



MINIMANIA APP CODE OF CONDUCT

Introduction

This document aims to establish clear guidelines for the expected behavior of MiniMania App players, with the aim of providing a safe, respectful and enjoyable gaming experience for everyone.

EXPECTED CONDUCT 👍

- **Interact with Respect:** All players must be treated with respect and consideration.
- **Maintain a Positive Attitude:** We encourage friendly interaction and mutual support between players.
- **Comply with Applicable Rules and Laws:** Make sure you comply with this code and the laws of your country.
- **Report Problems:** If you have any questions or problems, please contact our team at suporte@solarwishgames.com.

UNACCEPTABLE CONDUCT 👎

- **Abusive Behavior:** Bullying, harassment, threats or any form of abusive behavior will not be tolerated.
- **Inappropriate Language:** The use of offensive, prejudiced or discriminatory language is prohibited.
- **Rule Violation:** Cheating, use of *hacks*, *scripts*, theft of accounts, items or coins, and other violations of this or other MiniMania policies are strictly prohibited.
- **Disclosure of Information:** Do not share personal or private information of other players.
- **Illegal Activities:** Engaging in illegal activities such as casinos or harmful mini-games is strictly prohibited.
- **Explicit Sexual Content:** Any behavior or language of a sexually explicit nature, including *cybersex* and inappropriate content is prohibited.
- **Spam It is Flood:** Avoid sending or posting repetitive and unnecessary messages that may detract from the experience of other players.

- **Illegal or Suspicious Transactions:** The sale of items, coins or accounts for real money is prohibited, even if done between users of the Application. Transactions that involve fraudulent or illegal activities, such as money laundering or copyright infringement, are also considered suspicious. MiniMania Moderation has analysis tools and, through internal procedures, may, at its discretion, suspend and interrupt the user's access to the MiniMania App and purchased goods, when detecting suspicious transactions. This measure is a way to protect users from fraudulent or illegal activities.

PUNISHMENTS

Users who violate this code or other documents related to the MiniMania App or SolarWish Games Services will be subject to penalties that may vary from one **temporary muting** (mute) a **permanent suspension** (ban) and termination of access to any goods purchased through our Store or Catalog in the suspended user account. It is important to remember that we guarantee you a **limited** license that is **revocable** to access and use the content of the Application. The Application is **for your personal and non-commercial use only**. This license is revocable at any time and without the need to provide prior notice.
